Goldnev Resources Inc. (“Goldnev” or the “Corporation”) (TSXV: GNZ) is pleased to announce that it will hold a special meeting for shareholders on June 21, 2010. The purpose of the Special Meeting is to table a number of resolutions including a corporate name change. The Corporation is proposing to change its corporate name from Goldnev Resources Inc. to Blackstone Petroleum Inc.

The Corporation is also pleased to announce that it has engaged the investor relations firm ContactIR as of December 15, 2009 for a 6 month contract. ContactIR is based in Calgary, Alberta and specializes primarily in the petroleum sector as a strategic advisor and communications service firm. ContactIR is contracted to manage various aspects of Goldnev’s investor relations (IR) activities including the development of an IR program designed to bring broader awareness to the Corporation. The program will involve the development of consistent messaging and branding for Goldnev and all its related components. Additionally, the firm will be assisting with outreach activities and other marketing focused projects.

For providing services to Goldnev, ContactIR will receive a fee of \$5,000 per month. Goldnev is contracted to ContactIR to grant options to purchase 250,000 of Goldnev common shares. The pricing date and exercise price have yet to be determined. ContactIR has no other relationship with Goldnev and is not a shareholder of Goldnev.

Goldnev Resources Inc. is a public energy company focused on the exploration and development of conventional and unconventional hydrocarbons in northeastern British Columbia, southwestern Alberta and east central Saskatchewan. Goldnev shares trade on the TSX Venture Exchange under the symbol “GNZ.”
